- 3) If the equipment has a age or height limit please ensure no one over the said height/age limit uses the equipment.
- 4) The inflatables must be secured to the ground at all time.
- 5) No food or drinks are to be consumed on the inflatables (to avoid choking and mess).
- 6) All shoes badges and jewellery (e.g. large earrings, necklaces, etc) must 21) Do not allow users on the inflatables during inflation or deflation. be removed to avoid damage to the equipment and injury to other users. - 11) We will not set up in the event of torrential rain or high winds including gusts over 24mph. We have the right come and take down any inflatable during the party/event if we believe it's unsafe.
- 12) No smoking, barbecues or animals near the equipment.
- 13) Reckless or boisterous behaviour must not be allowed.
- 14) Avoid large children and small children from using the equipment at the same time.
- 15) Climbing, hanging and sitting on the walls/roofs is dangerous and damaging to the equipment and must not be allowed.

- 16) Children must use slides one at a time and must not climb on the sides of the slides.

- 24) Should a blower stop working immediately remove children from the inflatable.
- 25) Please inform us of any injury requiring professional medical treatment.
- 26) On adult equipment, adults and children cannot use the equipment at the same time. (Anyone under the influence of alcohol or drugs (prescription or otherwise) must not use the equipment.

On outdoor hires the wind speed should also be checked at regular intervals using the anemometer which would have been provided by the driver on delivery.

Please use the table below to record you readings throughout the day and return it to the driver on collection of the inflatable/inflatables.

If the wind speed exceeds 24mph the inflatable should be switched off. The internal pressure should be at least 1 KPA
